## PRESIDENTIAL CANDIDATES:



### JODIE LOLIK

Hi, my name is Jodie Lolik, and I would appreciate your consideration as a candidate for LSA President. Over my two years of involvement in the LSA, I have gained a real sense for how the LSA can benefit the student body, as well as in what areas work needs to be done. As a 1L committee chairperson and as a 2L Representative, I have learned how much an effective president can accomplish for the student body, for providing social activities is only the most visible of the LSA's duties. For instance, my involvement with the Graduate Student Center and the Pre-registration committee has given me the opportunity to develop a working relationship with our administration, a relationship conducive to furthering the interests of the students. As LSA President, I will use this foundation and my experience and my ideas to make the 1989-90 administration one that does not simply let things happen but one that *makes* things happen. I will work toward...

- ...revamping the Snack Bar as a Law Student Dining Facility and putting a full-size refrigerator and microwave in the Student Lounge (to be cleaned each week)
- ...requiring an LSA member to be in the office from 10 until 5, at least
- ...better communication with the University, including negotiations to establish separate alcohol and snow-day policies for the Law School
- ...ensuring the rebirth of the Speaker Series (I would appreci-

ate suggestions as to the "hot" issues)

...extending computer center office hours, especially at Memo and Moot Court time.

...listening to and cooperating with the other student organizations

...making certain that the Grad Student Center will be built and that the interests of both residents and non-resident law students will be protected (i.e. how much extra parking will be provided with the increased number of cars)

...speaking of parking, why do we continue to get tickets when there are no legal spots to be had? and why can't that lot be repaved?

...establishing an active academic affairs committee to help in the implementation of pre-registration, to publish "student perspectives" on classes they have taken, and to evaluate issues as the credits given to clinicals

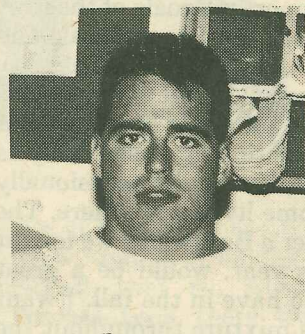
...opening communication between LSA and the entire student body by establishing a newsletter to be published once each semester and a suggestion box

...creating a "rec room" containing fitness machines to replace what was once available to us at Quonset Hut

...ringing in the next school year with a Barrister's Ball, subsidized so price is not a limiting factor...

ing board for controversial issues that may arise. Secondly this committee will provide student representatives to the faculty committees and correct the past problems of confusion and lack of participation in the important decisions of admissions, scheduling, and course evaluation.

3. I believe that we need better communication with the Main Campus Administration. Our problems have been brought to their attention on numerous occasions and if mass mailing and constant memo writing is the only way to emphasize the parking, lot re-paving and alcohol problems, then that route will be encouraged. Secondly, I will demand a full accounting of the increased funding made possible through our population growth. The money should be spent at the Law School, and I will make sure that L.S.A. budget is publicly printed in *The Alledger*.

4. I will propose, if the alcohol policy continues (i.e. cans), to make Bar Review a steady, bi-weekly event that is better supplied and theme oriented. Other social events, like the Dean's Prom, the Barristers Ball and Halloween Party will take place next year as planned. Other outside parties will be voted by the increased board, more accurately reflecting the social desires of the entire student body.

The L.S.A. Constitution provides a means for the law students to accomplish the goals we seek. I have spent two years demonstrating my willingness to put in long hours at the law school. I feel I know all the necessary angles and what it takes to get our goals accomplished. I feel that my past service and my enthusiasm are my best qualifications and the ones I stand by. Most of you know me and know that I will remain open to any and all of your future suggestions. I appreciate your interest and Thank Your for your support.

Over the course of the last two years I have worked in the law school community in numerous positions from Bar Review to Law Review, from running a fraternity to editing that highly awarded publication, *the Alledger*. While most of you know me only as the man behind Bar Review, my actual involvement is mainly behind the scenes in the L.S.A., organizing the softball season, the social events and working on specific problems with the administration, including the ever changing alcohol policy. My work thus far has been accomplished entirely through non-elected positions, and now that I have "resigned" from my present contributions, I hope to use the experience I've gained in the one focus of making the L.S.A. president an active and accessible position.

My platform is available around the school. However, I think it is worthwhile to state some of my goals.

1. I feel that the L.S.A. is perceived as "behind closed doors." organization with little contact with other student groups. It is this spirit that sets BCLS apart from other law schools that will remain anonymous (BU) and creates an atmosphere that eases the typical "law school tension" and is con-

ducive to forming friendships.

The President of the LSA is primarily responsible for Graduation ceremonies, including the search for a keynote speaker, compiling the Yearbook and organizing the Gala Ball. 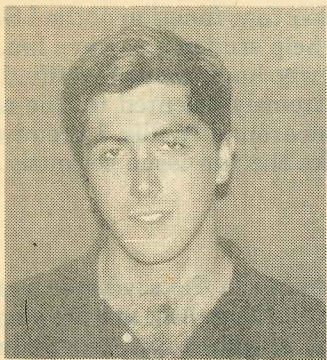
—Passive sentences are considered by many to be quite effective.

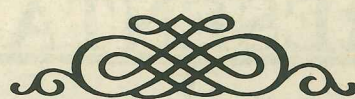

Finally, I believe that the loan forgiveness program is an essential element of the school's

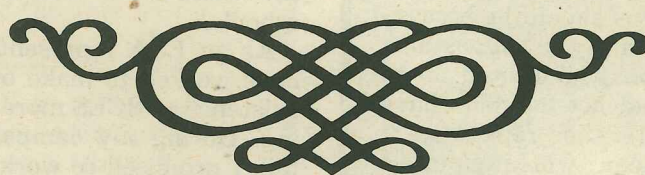
